## Presidents Report

We were fortunate that the fire ban was lifted at the eleventh hour before the annual Poker Run and Pig Roast on August 4. Attendance was high and by all accounts folks enjoyed the day. This was the first year that we have held the Annual General Meeting in conjunction with the Pig Roast, and we plan to do the same again in 2013. Once again, we want to thank the Feys and Barret families for hosting the event under the large red and white pines at the south of Cassels Lake.

As I write this (Nov. 7), most members have closed up for the season. We did experience a lot of rainfall on two occasions, in September and again in mid October (when nearly 3 inches fell in 36 hours), bringing water levels very close to overtopping many docks. On Oct. 15, OPG began lowering water levels and it is now below the danger range for dock surfaces. With regard to water levels, OPG was not generating power in summer 2012 as they were replacing penstocks at the Matibitchuan generating station, so there was no pressure to draw water from our system. However, we will need to keep a watch next year as there will undoubtedly be the competing desire by OPG to use the water resource for power generation.

I want to once again thank Ron Sullivan for the tireless efforts he put in over many years as CALA President. He kept careful watch over issues of importance to members and was diligent in following up where needed. I will rely heavily on his advice and support as Past President over the next two years. I would like to also thank all the CALA executive including outgoing directors, those who stood for re-election, and new directors, for volunteering to serve and contributing their time.

To all CALA members, we are still looking for new volunteers to stand for election so that CALA can continually update itself with fresh ideas and renewed energy. If you would like to offer your services as a future Director, please let me or any of the Executive know and we can advise you of the process and be sure you are nominated at the next AGM.



- Egg collection at Net Creek was 730,000 eggs
- Hatch rate was 57.5%
- Fry stocking 50,000 at Sunrise Creek
- Fry stocking at Net Creek 100,000
- No fingerling stocking
